15 YEAR LIMITED SYSTEM WARRANTY

## Limited Warranty

Kingspan Insulation LLC warrants to the owner of a building on which Kingspan GreenGuard® RainDrop® 3D Building Wrap, Kingspan GreenGuard® HPW™ Building Wrap, Kingspan GreenGuard® MAX™ Building Wrap or Kingspan GreenGuard® C2000 Building Wrap is installed that they will perform to Kingspan Insulation LLC's published specifications for a period of fifteen (15) years from date of purchase, if installed in strict accordance with installation instructions provided by Kingspan Insulation LLC and accepted industry standards in a properly designed and constructed wall system, and installed using Kingspan GreenGuard® Custom Seam Tape and Kingspan GreenGuard® Butyl Flashing.

Kingspan Insulation LLC will pay for the cost of labor and materials, at Kingspan Insulation LLC's sole option, to correct problems found to be caused solely by failure of *Kingspan* **GreenGuard®** RainDrop® 3D Building Wrap, *Kingspan* **GreenGuard®** HPWTM Building Wrap, *Kingspan* **GreenGuard®** MAXTM Building Wrap or *Kingspan* **GreenGuard®** C2000 Building Wrap that fails to perform according to the product specifications for water and air resistance for fifteen (15) years after purchase.

This Limited Warranty does not apply to damage due to abuse or mishandling of the product, improper installation, or damage which is caused primarily by someone or something other than Kingspan Insulation LLC's product. This Limited Warranty is the user's sole and exclusive remedy under tort, contract, or statutory law. The Limited Warranty is provided for all purchases of *Kingspan* **GreenGuard®** RainDrop® 3D Building Wrap, *Kingspan* **GreenGuard®** MAX™ Building Wrap or *Kingspan* **GreenGuard®** C2000 Building Wrap made on or after September 1, 2016.

For the registration to be valid, the initial building owner must submit a *Kingspan* **GreenGuard®** Warranty Registration Form with proof of purchase (letter or invoice from contractor, building material supply company invoice) to Kingspan Insulation LLC at the address below.

Any claims under this Limited Warranty must be made in writing to Kingspan Insulation LLC at the above address within 90 days of discovery of the issue giving rise to the claim. To be valid, all claims must identify the building address, the warranty claimant and the nature of the claim. If Kingspan Insulation LLC determines that an investigation of the claim is necessary, the claimant must allow access to a Kingspan Insulation LLC representative to view the property specified in the claim, including the taking of photographs and samples as required.

Except for the above limited warranty, Kingspan Insulation LLC makes no other warranties, express or implied, and disclaims all other such warranties, including but not limited to warranties of merchantability and fitness for a particular purpose, if such implied warranties cannot be waived under applicable law, they will only be applicable for one year after the initial purchase of the product. Other than its obligations under the limited warranty above stated, in no event shall Kingspan Insulation LLC be liable to any person for any direct, indirect, special, incidental or consequential damages of any kind, including but not limited to lost profits or revenue, loss of use, personal injury or damage to property contents.
